NEWS LITERACY IN SCHOOLS: IN THE 2020-21 SCHOOL YEAR, NLP ENGAGED OVER 13,000 EDUCATORS WHO ACTIVELY USED OUR PROGRAMS AND RESOURCES. WE ESTIMATE THAT THESE EDUCATORS REACHED APPROXIMATELY 2 MILLION STUDENTS NATIONWIDE. DESPITE NOT BEING ABLE TO GATHER IN PERSON DUE TO THE COVID-19 PANDEMIC, NLP SERVED MORE EDUCATORS AND REACHED MORE STUDENTS WITH NEWS LITERACY PROGRAMS AND RESOURCES THAN EVER BEFORE.
