ENGAGING EDUCATORS: DURING THE 2022-23 SCHOOL YEAR, NLP ENGAGED 13,450 EDUCATORS NATIONWIDE WHO ACTIVELY USED NLP'S PROGRAMS AND RESOURCES, INCLUDING THE CHECKOLOGY VIRTUAL CLASSROOM NLP'S AWARD-WINNING DIGITAL LEARNING PLATFORM. WE ESTIMATE THAT THESE EDUCATORS REACHED APPROXIMATELY 2 MILLION STUDENTS ON A NATIONAL SCALE.
